RENTAL TERMS AND CONDITIONS

PRICES

- Prices are not contractual and can be modified without any prior notice. The contractual price is the one set at the time of booking.

RESERVATIONS

- All reservations must be booked in the name of a person (hereinafter the "rentee") and are not transferable. The signatory must be an adult.
- The reservation will be complete upon receipt of this signed contract and settlement of the deposit, subject to its acceptance by the camp-site management. Confirmation will then be sent by post or by email.
- The outstanding balance for your stay should be paid for 15 days before your arrival in the case of a vacant camping plot, and 30 days before your arrival in the case of rental accommodation.
- Should this balance remain unpaid within the aforementioned periods, the reservation will be cancelled and the deposit will be kept by the camping site.

ARRIVAL AND DEPARTURE

- Camping plot: arrival after 14h, departure before 12h
- Rental accommodation:
 - Overnight stay*: arrival after 15h, departure before 11h
 - Week-end:* arrival on Friday after 15h, departure on Sunday before 18h
 - Weekdays: arrival after 16h, departure before 10h.

Any overstays of more than one hour will be invoiced as an additional night.

* not applicable in July/August

LATE ARRIVAL/EARLY DEPARTURE

- No refund will be given in case of late arrival or early departure. Late arrival of over 24h without warning may lead to cancellation.

CANCELLATION

- Cancellation should at all times be communicated in writing.
- Any cancellation request more than 15 days or 30 days before the agreed date of arrival for a camping plot or rental accommodation will imply a breach of contract and a forfeit of 25% of the total cost of the stay.
- Any cancellation request made within 15 days before the agreed date of arrival for a camping plot or within 30 days before the agreed date of arrival for rental accommodation will imply a breach of contract and a forfeit of 100% of the total cost of the stay.
- The camp site recommends that the rentee buy a travel cancellation/trip interruption insurance (terms and conditions available on demand and may be consulted on-line on our web page www.lafretille.com).

Any misleading statements made by rentee will render this contract null and void and any amounts paid will be retained by the camp site.

DEPOSIT (Rental accommodation)

- A deposit of €250 per accommodation will be requested upon arrival. These amounts will be returned on the day of departure, following an inspection of the premises in your presence. The accommodation must be left perfectly clean, otherwise a cleaning charge of 60 € will be immediately invoiced.

ANIMALS

Accepted on camping plots, but not authorized in rental accommodation. A single animal (dog, cat) is authorized per camping plot, subject to notification at the time of making the reservation and following its acceptance by the camp-site management. The vaccination record should be up to date and must necessarily be presented to the reception desk on arrival. Animals must be kept on a leash and if not calm and non-aggressive will otherwise risk immediate expulsion from the camp site. Category 1 and 2 dogs are prohibited on the camp site. LIABILITY

- Civil liability insurance is obligatory for the rentee. Beyond its liability under law, the camp site management will not be held responsible for any theft, loss, or damage that may be occasioned.

CUSTOMER SERVICE

- In the event of a dispute and after appealing to the customer service department of the establishment, all campsite customers have the possibility to call upon the customer ombudsman, within a maximum delay of one year from the date of the written claim by registered mail with acknowledgement of receipt to the establishment.
